

TERMS AND CONDITIONS FOR “WESTFIELD PLUS LOLLIPOP’S PLAYLAND ULTIMATE KIDS PARTY COMPETITION” 2022 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Knox **Westfield Plus Lollipop’s Playland Ultimate Kids Party Competition**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on VIC local time.

ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 14 years or over**.
3. Entrants under 18 years old must have parent/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Knox Shopping Centre (“**Participating Centre**”) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

5. This Promotion commences on **Friday 13 May** and ends at **5.00pm AEST** on **Sunday 22 May** (“**Promotion Period**”).

HOW TO ENTER

6. To enter this Promotion, eligible individuals must, during the Promotion Period, undertake the following steps:
Visit the promotional cart located near Kmart or the Concierge Desk located on Level 2 near Baby Bunting. Show their Westfield Plus membership barcode to the staff. Once verified, staff will provide the individual with one entry card into the draw. All lines in the entry card must be filled out accurately. The entry card will then be returned to the staff and entered into the draw. The first 50 members to enter the draw at the activation cart near Kmart each day during the activation period (11am – 2pm, 13/5 – 15/5 and 20/5 – 22/5 ONLY) will be eligible to redeem ONE free entry ticket to Lollipop’s Playland Knox (valued at \$12.90).

LIMITS ON ENTRY

DRAW DETAILS

8. The draw will take place at the Participating Centre, Centre Management, 425 Burwood Highway, Wantirna South, VIC 3152 at **11am on Tuesday 24 May**. The Promoter reserves the right to draw additional reserve entries in case of an invalid entry or invalid entrant.

WINNER NOTIFICATION

9. The provisional winner(s) will be notified with **a phone call on the contact number provided on the competition entry card**. A provisional winner will only be deemed a winner once verified by the Promoter. Any VIC winner of a prize valued at over \$1,000 will have their name and postcode published online at **westfield.com.au/knox** from **Thursday 26 May**.

PRIZES

10. The first valid **entry** randomly selected, from all valid entries received, will win the prize of The Ultimate Party Pack with Build a Bear for 30 children at Lollipop's Playland Knox valued at AUD\$1,500.80. Party must be booked within 6 months of competition draw.

GENERAL

Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to

disqualify any entrant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.

26. The Promoter's decision is final and no correspondence will be entered into.
27. Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the Scentre Group of companies (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.
28. PRIVACY
