

## TERMS AND CONDITIONS FOR “WESTFIELD HORNSBY Ultimate Burger Day pack” PROMOTION 2022

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Hornsby Ultimate Burger Day pack” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

### ELIGIBILITY

2. Subject to condition **3**, this Promotion is only open to Australian residents **aged 18 years or over**.
3.
