# TERMS AND CONDITIONS FOR "WESTFIELD COOMERA" WESTFIELD PLUS BURGER DAY 2022" PROMOTION

 Information on how to enter and prizes form part of these Terms and Conditions. Participation in this "Westfield Coomera "Westfield Plus Burger Day 2022" Promotion ("Promotion") is deemed acceptance of these Terms and Conditions. #### **ELIGIBILITY**
