# TERMS AND CONDITIONS FOR "WESTFIELD TEA TREE PLAZA: Westfield Plus Burger Day Spin and Win" May 2022 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. #### **ELIGIBILITY**
