

TERMS AND CONDITIONS FOR “WESTFIELD CHATSWOOD SAN CHURRO VOUCHER” PROMOTION 2022

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Chatswood **San Churro voucher** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 14 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Chatswood Shopping Centre (**“Participating Centre”**) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

5. This Promotion commences on **11 July** and ends at **6pm AEST/AEDST** on **17 July** (**“Promotion Period”**).

HOW TO ENTER

 - Spend at any dining or entertainment retailer within Westfield Chatswood
 - Scan the QR code at the concierge desk
 - Present your redemption screen and receipt to the concierge staff
 - Receive 1x San Churro: Churros for 2 voucher

LIMITS ON ENTRY

7. Multiple entries permitted per person, per day however each entry must be **substantially unique** and submitted separately and in accordance with entry requirements.

DRAW DETAILS

8. The draw will take place at the Participating Centre, Centre Management, 1 Anderson Street, Chatswood, NSW 2067. The Promoter reserves the right to draw additional reserve entries in case of an invalid entry or invalid entrant.

WINNER NOTIFICATION

9. The provisional winner(s) will be notified in writing within two (2) business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter.

GENERAL
