

TERMS AND CONDITIONS FOR “WESTFIELD MARION: Westfield Plus Chocolate Day Giveaway” July 2022 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Marion: Westfield Plus Chocolate Day Giveaway” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on SA local time.

ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 16 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Marion Shopping Centre (“**Participating Centre**”) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

HOW TO ENTER

 - Open the App, using their mobile device, in a Participating Centre; and then
 - Locate the Activation in the Participating Centre and scan the QR Code for the giveaway.
 - Show the redemption success screen to the ambassador at the activation for the ambassador to verify their entry. Once verified,
