

TERMS AND CONDITIONS FOR “WESTFIELD PARRAMATTA – WSW JERSEY ONLINE COMPETITION” PROMOTION 2022

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Parramatta – WSW Jersey social competition” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

ELIGIBILITY

2. Subject to condition **3**, this Promotion is only open to Australian residents **aged 18 years or over**.
3.
