

# KARMABLY 'DOGA' WAIVER

## 1. Consent

Participants willingly chose to participate in this event and understand that they are undertaking the presented activity, Dog Yoga, at their own risk.

## 2. Right to Remove

The facilitators, instructors, and staff retain the right to exclude people from the event for any reason (including the reasons below). Additionally, if the participant display flu-like symptoms or feeling unwell, the team at Karmably, employees, and agents reserve the right to remove the participant from the event.

**Vaccinations/ Insurance/ Health of Pet(s):** Participants warrant their pet/s to be current with all vaccinations/ insurance and is in good health to the best of their knowledge.

**Aggressive Dogs / Parasites:** Karmably reserves the right to refuse service, or to stop service in progress, if pets pose a threat to themselves, other dogs, and/or staff, by either aggressive or other behavioural issues or any health problem.

**Owner Responsibility:** Participants agree to be solely responsible and liable for all acts of behaviour by their pet(s).

## 3. COVID-19 Safety Information

While participating in events held or sponsored by Karmably, participants are encouraged to sign-in using the QR Code, practice hand hygiene, "social distancing" and wear face coverings to reduce the risks of exposure to COVID-19. Participants hereby release, waive, discharge and covenant not to sue the Releasees from any claims whatsoever on account of any first aid, treatment, or service rendered to them during the activity. The participant hereby agrees to indemnify and hold harmless the releasees from any loss, liability, damage, or costs, including court costs and attorneys' fees, that they may incur due to the participant during the activity.

## 5. Audio and Visual Content
